GENERAL ELIGIBILITY CRITERIA

- A. Persons to be formally and publicly recognized in the SAHF must have, in the course of their residence in Saskatchewan, made significant contributions to the welfare and improvement of Saskatchewan Agriculture, and to a better way of life for the farm family.
- B. Candidates for induction must have made unique contributions beyond the local level. The acts for which they are recognized must have benefited farm families on a Provincial level at least. National, or International contributions enhance eligibility.
- C. Nomination, which must be made on this form, will be reviewed by a Research Committee. If the application is approved by the Selection Committee, you will be contacted to identify possible sponsoring organizations. If the application is not approved within three years it will lapse unless further evidence of eligibility is submitted. Do not advise the nominee of your application to avoid disappointment if not approved.
