

Nomination Form for Induction

General Eligibility Criteria

- Persons to be formally and publicly recognized in the SAHF must have, in the course of their residence in Saskatchewan, made significant contributions to advancing agriculture in the province.
- Candidates should have made an exceptional contribution to Saskatchewan society and rural communities over a period of many years.
- Candidates must have made significant contributions beyond the local level. National or international contributions enhance eligibility.
- Recognition is based on each candidate's lifework in terms of contributions to agriculture. Nominees should be in the latter stages of their careers or retired.
- This application form must be used for nominations and should include three to six one-page support letters. The nomination must also include an induction fee (\$2,000 for individuals or \$3,000 for couples) if selected.
- Should the nominee(s) be selected, the fee will be invoiced after the induction announcement.
- Nominations for couples will be considered using the same criteria as individuals. The case must demonstrate that both members contributed equally.
- Nominations remain on file for up to two additional years after the initial application year.
- Typed nomination forms are strongly encouraged for legibility reasons.
- Nominations must be received by September 1st to be evaluated for the following year.
